HKJA Membership Guidelines 申請入會須知

I. Documents Required 申請文件

- 1. Your business card or a photocopy of your staff card 工作名片或證件副本。
- 2. A passport photo (soft or hard-copy) 證件相片(數碼相片或硬照)
- 3. For freelancers, please provide copies of your published articles in the latest 12 months (printed version, photocopy version or link).

自由撰稿人請提供最近一年已刊出的作品。印刷本、列印本或報道的超連結均可。

- 4. For students, please provide a photocopy of your student card. 學生請提供學生證副本。
- 5. To ensure that membership meets the requirements of the Trade Unions Ordinance and the Constitution of the HKJA, applicants may be required to provide proof of income, if necessary.

- 6. Please pay the membership fee only after the application is approved. Applicants should provide bank slip/transaction proof for application handling. 申請獲得通過後,才需繳交會費。申請人須提供會費入數證明以便完成手續。

II. Membership and Annual Subscriptions 會籍及年費

- 1. Membership last for one year. 會籍為期一年。
- 2. For Full / Associate / PR member renewing membership, the yearly subscription is **HK\$250** (including entrance fee of HK\$50 and yearly subscription HK\$200). 正式/附屬/公關會員申請人的會費為港幣 250 元 (包括入會費港幣 50 元和年費 200 元)。
- 3. The student membership fee is HK\$50 for a full year with entrance fee waived. 學生會員會費為港幣 50 元,豁免入會費。

III. Press Card 記者證

- 1. A Full Member can apply for the HKJA Press Card and IFJ Press Card, subjected to the approval of the Executive Committee.
